The CME Review Committee meets the first Wednesday of the month (January – June) and the second Thursday (July – December) to discuss applications. The deadline to submit your applications is <u>3 weeks prior to the meeting</u> to allow adequate time for the Office of CME to do a review prior to sending it to the committee.

The Office of CME will not accept applications <u>less than 3 months prior</u> to the date of the activity. The coordinators of a conference should not promote or request funding (grants or exhibits) until an application has been approved for CME.
